- 4. The Participant agrees to display the supplied signage from LJ Hooker Yarrabilba Property Complete for the purposes of this competition and to identify their entry respectively. The Participant agrees that the signage must not in any way be tampered with, altered or intentionally/maliciously damaged and to display the signage in a clear and visible way.
